The International Lake Constance Region






Principality of Liechtenstein

IBK at a glance





- 1972: 1st Lake Constance Conference
- 1979: Statute, 6 members
- 1998: 10 countries and cantons
- 1994, 2008: Mission statements
- 2017: IBK mission statement + strategy
- Voluntary, no legal form
- Annual change of presidency
- Consensus principle
- Budget approx. 1.5 Mio. € / p.a. for projects; 410'000 € / p.a. to run the head office
 → from membership fees


IBK Small Project Fund



Framework Conditions I



- According to the Cooperation Program (Interreg VI-A) Germany-Austria-Switzerland-Liechtenstein small project funds (SPF) focus on projects with total project costs of max. 200,000 €.
- Small projects (recipients) receive support from the ERDF via the small project fund in accordance with Art. 25 (1) ETC Regulation.
- The support from the ERDF can also flow into small projects outside the EU as long as the fund has its seat within an EU Member State participating in the Interreg program (Art. 23 para. 7 ETC Regulation).
- The SPF can dispose of the ERDF funding as a sole beneficiary.
- The funding rules of the Interreg program do not apply to the small projects, but only to the SPF itself.
- Small project funds have its own funding rules in compliance with the requirements of the ETC-Regulation, in particular Art. 25 (6).

Framework Conditions II



The funding rules of the SPF must consider:

- Simplified cost options must be applied as a matter of principle
- real costs are accepted only under exceptional circumstances (public contribution more than 100,000, subsidy or lump-sum financing), (Art. 25 (6) of the ETC Regulation).
- In particular, real costs are not accepted in combination with unit costs (standardized unit rates)
- Draft budget is possible but actually not used
- Staff costs can be claimed as a flat rate of 20% or as standardized hourly rates. Different hourly rates than for EU recipients can also be applied, in particular for recipients from Switzerland or for Liechtenstein.

Framework Conditions III



The funding rules of the SPF must consider:

- Public Procurement Law: the law of the state applies in which the recipient has its registered office. Thus, if a Swiss partner carries out a tender for the project, Swiss public procurement law applies.
- SPF is free to set its own funding rates in its regulations –
 observing the general principle of equal treatment and not exceeding
 the funding rate approved by the Interreg program.
- The SPF beneficiary (IBK) disburses the funding to the small projects. Reimbursement of these costs is made within the framework of the Interreg rules for small projects (NB: there is a second SPF funded from IBK's members only). Thus, the SPF-beneficiary should be able to make an advance financial payment to the small projects.

Framework Conditions IV



The funding rules of the SPF must consider:

- Management verification (FLC) of the costs of small projects (final recipients) is carried out by the SPF beneficiary of the small project.
 Second level control also covers the reliability of the indicator system (transparent and comprehensible method basis).
- The selection of small projects is made by a selection committee appointed by the SPF-beneficiary.
- Selection criteria must meet the requirements of Article 25 (3) of the ETC Regulation: non-discriminatory, transparent selection procedure, objective criteria, evaluating the project applications must follow a kind of "methodology".
- In terms of content, there are no specifications other than a crossborder effect of the project is required. Applicant can thus be only one organisation (as 'sole recipient').
- Article 23 of the ETC Regulation does not apply to small projects funded by an SPF.

Key Points of the IBK Small Projects Fund 2023-2028

- Cooperation and financing by all IBK member countries; lead partner: state of Baden-Württemberg, represented by IBK office
- Concept: broad range of target groups, thematic diversity of projects, clearly defined eligibility and exclusion criteria, international selection committee with rules of procedure, maximum support rate following the minimum for standard projects, budget for funding projects approx. 1.2 million euros.
- Coordination/project consulting by a 60% position (0.6 FTE)
- Co-financing of administrative costs (coordination office, material and travel costs, public relations, etc.) by the IBK, cofinancing of project costs by the recipients of the small projects.
- Dual-track orientation of the fund (see below)
- Project selection by an international selection committee:
 - Voting members: one representative for each, i.e. the German members and the Austrian member, one for Swiss cantons and one for Liechtenstein plus the IBK managing director
 - In advisory capacity: A representative of the Joint Secretariat Interreg ABH, the project coordinator and the deputy managing director (responsible of controlling)













Funding rules



No draft budget: too complicated! Use of different flat rates depending on individual needs - Choice between two options:

More external cost & services than staff costs:

- External cost & services costs as real costs (to prove with invoices) plus
- 20% flat rate for staff
- Office & administrative costs as flat rate of 15% of staff
- Travel costs as flat rate of 5% of staff costs

More staff than external costs & services:

- Staff costs based on standardized hourly rates (unit cost) and timesheets according to Interreg-Program
- Flat rate of 40% for the remaining eligible costs (calculated expenses must be presented with the application)

ABH023: Civic projects (SZ11)

- Project budget: 900.000 € / ERDF: 630.000 €
- Target group: citizens, associations, initiatives, organisations, municipalities.
- Goal:

to promote cross-border neighborly contacts on various social levels as well as exchanges highlighting similarities and differences in everybody's everyday life thus contributing to a deeper understanding of neighboring countries.

Factors of success



- close cooperation with the Interreg program
 - consideration in program design
 - elaboration of regulations
 - project selection

- long experience
- proven concept
- high level of confidence
- decision-making selection committee
- very intense consulting of applicants


CO2-Reduktion in the building sector

Example ABH023: Civic Projects (SZ11)

- Students research, conducts and interviews, visits each other, Author readings, audio-files


