

Longer term prioritisation

Core development phase till end of Q1 2024: Provision of the whole programme and project workflow Additional "horizontal" features (to be prioritised with care)

Additional developments till end of 2024:

Adding the most valuable features from a (quite large) collection of suggestions





Won't dos

- Input locking
- Organisations (identify same organisations across projects)
- System privileges enhancements (remove roles, description, apply changes immediately/log out user upon change)
- User customization (appearance, dashboard etc.)
- Enhanced co-financing (depending on NUTS, legal status of partner, predefined contributions)





Candidates for additional development phase

- Checklists enhancement (select per call, clone, compare, date, explanation field)
- e-signature
- Extended file management (file section on programme level, call files, sorting and filtering, versioning)
- Advanced AF modifications (lock AF sections, applicant can request modification, deadlines, MA/JS can do minor modifications)
- Project dashboard (statistics on spending and achievements)

Testing on many levels

During coding:

- mutual tests by developers
- acceptance test by Interact

Manual "regression tests": every week with 3-4 colleagues from cloudflight & Interact

Automated tests:

- run every night
- 165 business-relevant test cases currently identified, this figure is still growing
- more than 100 of these test cases are automatised to date

Release testing:

- week before release, all team and Core Group
- all new and selected existing features, stress tests

User tests:

- Once a feature has been finished
- programme users with various roles
- Testers are instructed step by step
