

Weaknesses

Life-cycle costing (LCC) means considering all the costs that will be incurred during the lifetime of the product, work or service:


- Purchase price and all associated costs (delivery, installation, insurance, etc.)
- Operating costs, including energy, fuel and water use, spares, and maintenance
- End-of-life costs (such as decommissioning or disposal) or residual value (i.e. revenue from sale of product)

The EU GPP criteria are developed to facilitate the inclusion of green requirements in public tender documents. While the adopted EU GPP criteria aim to reach a good balance between environmental performance, cost considerations, market availability and ease of verification, procuring authorities may choose, according to their needs and ambition level, to include all or only certain requirements in their tender documents.





- Limited Funding Opportunities



Suggested Actions to Facilitate NbS procurement

• Use pilot projects to build trust in the community

- Consider grouping NbS contracts together
- Join NbS networks

To the test - -->

Grant Scheme to support Community Councils with climate measures (National Recovery and Resilience plan)

- Redevelopment and/or landscaping of public spaces with permeable materials
- Implementation of Sustainable drainage systems in public pedestrian areas and squares
- Tree plantings in public pedestrian areas and squares, existing outdoor parking areas, public parks, playgrounds, etc.
- Construction of cycle lanes/cycle paths and pedestrian paths

To the test - -->

Grant Scheme to support Community Councils with climate measures (National Recovery and Resilience plan)

Tree plantings in public pedestrian areas and squares, existing outdoor parking areas, public parks, playgrounds, etc. ٠

Minimum requirements:

- Native and endemic species
- 2. Invasive species are forbidden
- Permanent irrigation system should be installed and maintenance programme should be established. The maintenance program should be in place and implemented for at least eight (8) years after planting 3.
- The planting period should be between November and February 4.
- 5. Investments may not be applied to scattered individual green areas which are not open to citizens
- 6. Tree planting should provide natural shade for pedestrians and public areas
