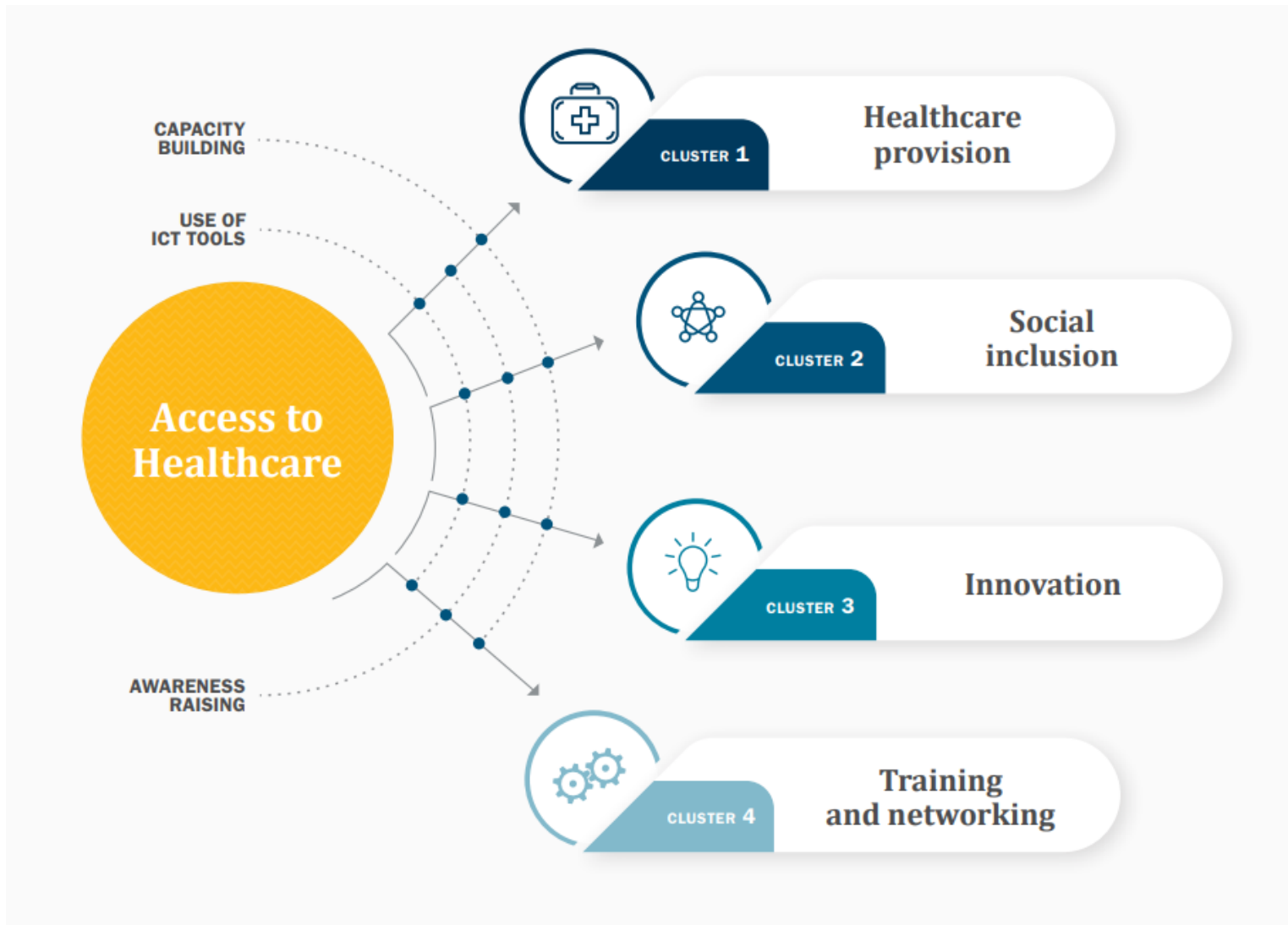

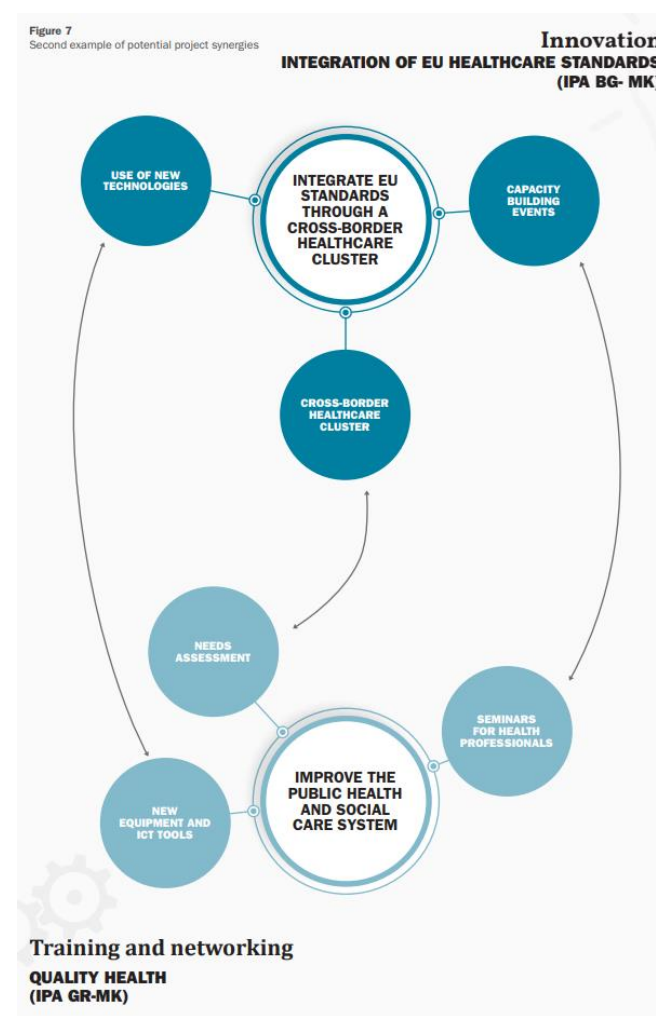

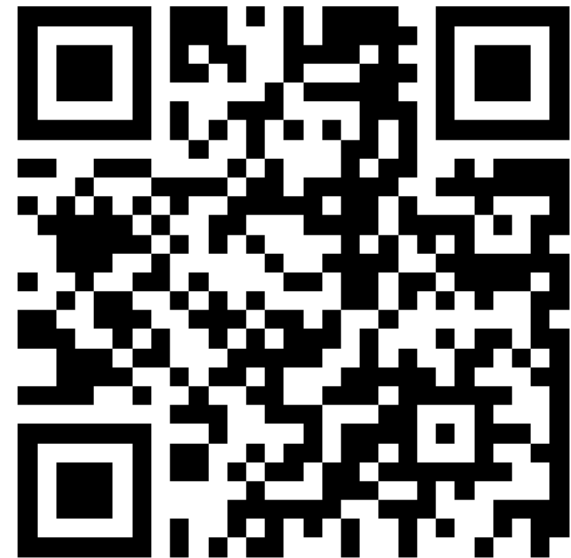
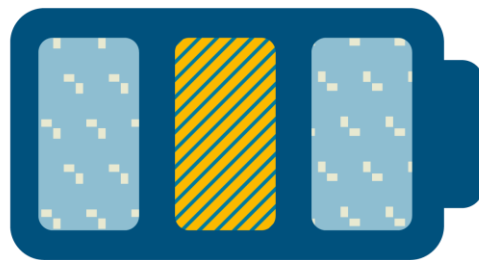
Lessons learnt for 2021-2027

- Take advantage of complementarities with regional/ national/ EU programmes (ERDF, ESF) and EU level programmes (EU4Health, Horizon Europe) to continue developing 'Healthcare provision', 'Social inclusion', 'Innovation' 'Training and networking'.
- Develop synergies between projects using the combined potential of their outputs to multiply their effects.
- Organise inter-programme thematic meetings and exchanges to develop synergies between projects not only within their respective programme, but also between projects funded by different programmes.
- Encourage project actors to answer new needs such as mental issues in young people, going beyond the explored topics when necessary.
- Adopt a more structured territorial approach by creating functional cross-border public health services when possible.



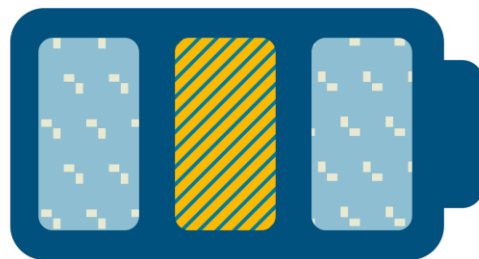

What did the COVID-19 Pandemic reveal about the health of our systems in border areas?

- Border closures in some cases made no exception for emergency patient transfers
- Cross-border (frontier) healthcare workers not guaranteed passage to workplace – resulting in inability of healthcare systems to provide safe staffing levels
- Efficient and effective use of total hospital beds in border regions prevented by centralised healthcare systems not looking across the border – proximity principle was not exercised
- Some regions responded quickly with high level political resolutions to improve the situation (e.g. Grant-Est FR)
- Significant opportunity for Member States to avail of existing EU legal mechanisms (Directive, Social Security Regulation) to address emerging crisis in planned care
- Embedding the learning now is crucial- resilience for next pandemic and strengthening overall health systems across EU by supporting capacity in border regions for best use of all available resources and infrastructure
- Those regions which thought spatially in cross-border terms were able to innovate
- Local government, regional government, municipalities were crucial as structures closest to citizens.
- 40% EU Citizens live in a border region- the right to health must be manifested and expressed if we are to give meaning to principles of cohesion/integration/resilience and recovery- we know what the tools need to be and Interreg is a crucial enabler of experimental approaches which then need to be embedded into normal practice- importance of having ALL relevant decision makers connected
- Multi-level governance involving territorial co-operation for health is the key to the future- national/subnational/regional/service users/citizens – CODESIGN!
- Place-based responses to health and healthcare co-operation/population health are both WHO best practice and have a better chance of meeting needs on the ground.

Challenges of Cross Border health and co-operation

- Co-operating across borders on healthcare or any aspect of the business processes underpinning this (including data collection) is complex, challenging and requires taking into account differences in national systems as well as a deep understanding of the interface issues between health systems. Without good data these challenges increase.
- Lack of understanding of benefits to whole healthcare system of innovative approaches in border regions- release potential, not drain resources. Better understanding needed of SMARTNESS of territorial (CB) complementarity in overstretched systems with limited resources.
- Better data on patient movement and population health needs in border regions is needed.
- Border regional authorities and municipalities have a key role- border regions as laboratories of European integration. Political leadership essential facilitator of progress.
- Challenges range from emergency care co-operation, healthcare workforce planning (mutual recognition of qualifications, taxation and social insurance issues for frontier healthcare workers, inconsistencies in approaches to reimbursable healthcare expenses under Directive and Social Security Regulation.
- Challenges can't be solved by Member States working alone- the regions are key partners as are regional healthcare providers



Mobilising our Existing Assets:

- Bilaterals between member states- Ostbelgien Regelung



Mobilising our Existing Assets

Existing arrangements which support the necessary co-operation for health at borders: Existing arrangements which Support CrossMobility (Collaborative Working)

- Institutional partnerships in border regions- healthcare institutions, civic authorities, partnerships between insurers;
- Effective and appropriate multilevel governance solutions with the right partners involved;
- Euregio Maas Rhein, EUPrevent, EPECs, OFBS, HealthAcross are all examples of subnational/regional institutional capacity for supporting cross-border health co-operation and patient mobility pathways;
- EU INTERREG Programme has provided an crucial source of support for capacity to be developed.
- Governance obstacles remain- focus needed on this to ensure sustainability of patient pathways and access.



AEBR – AGEG – ARFE

Opportunities for co-operation and the EU Interreg Programme

Address the proximity principles through development of shared healthcare services in border regions- adds value to the whole Member State healthcare system and improves health status of citizens in border regions;

Pay attention to the front office (patient/citizen-facing, information on entitlements and user-friendly processes for accessing care);

Pay attention to the back office (institutional co-operation, service planning collaboratives that draw on and develop good data to support their activities, joint care planning, joint workforce development, healthcare workforce mobility, recognition of qualifications, virtual healthcare solutions)

Measures which address language borders in provision of healthcare (HealthAcross-Austria/Czechia/Slovakia)

Shared healthcare services based on cross-border patient catchment model of feasibility (ES/FR Cerdanya Hospital, IE/NI Cross Border Cancer and Cardiac Services)

Shared approaches to procurement of high-cost clinical equipment e.g. diagnostics (Euregio Maas-Rhein aiming to progress this)

Interventions aimed at addressing health inequalities in border regions including Gender-specific medicine and prevention/early intervention

Regional cross-border territorial approaches to data collection and use of data for planning services and infrastructure for health (Grand-Est FR)- link to Spatial Planning agenda, EU Smart Regions,

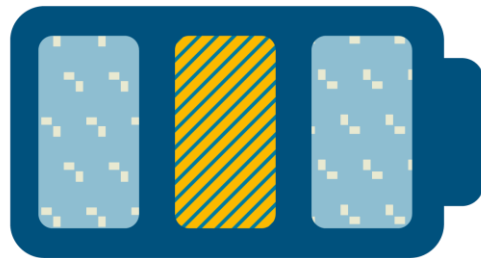

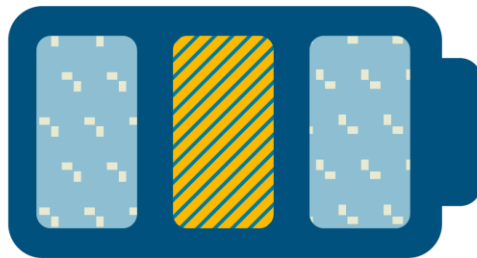

Health can be addressed in many ways:

- PO1: RDI, 3S, e-gov, e-health
 - PO4: healthcare access and provision, skills, social economy, inclusion
 - PO5: territorial multidimensional strategy, bottom-up governance
 - ISO1: systemic approach to cooperation, long term perspective (solve legal obstacles, CB data collection, trust building, capacity building, pilots)
- 27 programmes selected SO 4.5 (mainly CBC) for 364M ERDF investments (about half a bn in total)

Cooperating

- ✓ Better coordination between Interreg programmes
 - Border focal point, **Interact Inclusive Growth network**

- ✓ Embedding of cooperation in mainstream programmes
 - Based on art.22 CPR (for structural funds), but also PNRR and other national policy and funding frameworks. Benefits: more ambitious projects, new partners, complementarities and synergies, visibility

- ✓ Bilateral agreements
 - Ex.: Agreement between ES and FR on recognition of qualifications (from Cerdagne b-solution case)

 - Quirinale Treaty between FR and IT (establishing a cross border committee for healthcare)

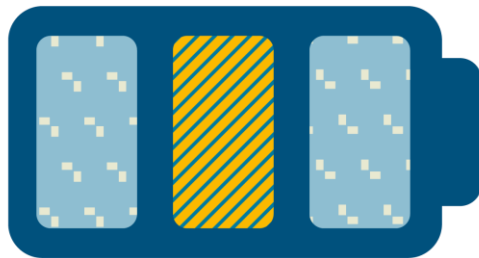
