# Vacancy announcement for the Interact Programme

# Interact Office Turku - Specialist in Interreg programme and project implementation and management

We are looking for a specialist in Interreg programme and project implementation who will advocate, facilitate and support change in approaches and programme management practises through various digital tools and face-to-face experiences. This position requires a strategic view for the future, analytical thinking, and strong communication and cooperation skills.

#### What are the key tasks?

- analyse and interpret EU regulations, actively contribute to discussion regarding legal framework 2021-2027 and preparations for the period post 2027;
- support, analyse and lead discussions on Interreg programmes' procedures and practices for more effective operational management and implementation;
- support discussion and building of synergies and cross programme (and project) coordination, facilitate exchange experiences for territorial development;
- develop and deliver events, including advisory services, trainings, workshops, meetings, etc. (incl. concept development, practical organisation, management, moderation, reporting and follow-up processes) in face-to-face and online environments;
- develop and lead network(s) supporting the service delivery within the field of responsibility;
- facilitate processes in the Interreg community that lead to harmonisation and simplification of practices;
- support, and if necessary, substitute Interact experts in service delivery within the field of expertise;
- perform tasks according to the needs of Interact, Interreg programmes and projects, and other key stakeholders of Interact.

The position could involve travel and occasional work outside regular office hours.

#### Who we are looking for?

The following professional skills/assets will be advantageous for the position identified, and we will be looking at the combination and match between experience/qualifications and skills/assets. We will also look at the professional and personal traits and skills that each candidate can bring to the team and the position.

# The minimum requirements for this position, and which applicants should regard as eligibility criteria, are:

- Master or post-graduate degree (or equivalent) in relevant fields of study (EU- or international studies, public management, economy, social studies or related field);
- At least 5 years of working experience with Interreg programmes and projects;
- Proficiency in written and spoken English.

#### Knowledge that is necessary for this position is:

- extensive knowledge and understanding of EU Regional Policy and regulations;
- in-depth knowledge and understanding of Interreg programmes and their projects, including their implementation and management processes;
- thorough understanding of complementing EU funding instruments to support European territorial cooperation;
- in-depth knowledge in topics like roles and responsibilities of programme management and implementation bodies, programme implementation cycle, monitoring and evaluation, legal framework 2021-2027, project life-cycle, coordination and synergies;
- experience in designing and delivering learning content, providing and facilitating workshops (online, in-person, hybrid);
- knowledge and experience in organising, leading and monitoring networks of experts in the relevant field of responsibilities;
- IT literacy;
- understanding of and ability to apply change management principles and knowledge transfer are considered an asset.

#### Skills/assets that are essential for this position:

- commitment and drive for high-quality results, even under changing circumstances;
- ability for analytical assessment and critical thinking;
- courage to contribute to developments and accept new challenges;
- capacity to hold a strategic view of the future, at the same time having an eye for detail;
- independent, yet team player with a service-minded approach;
- strong sense of initiative and personal responsibility;
- strong communication and presentation skills;
- motivation and capability to work in an international team in the multicultural environment;
- disciplined, with good planning and organisation skills;
- ability to establish and maintain effective relationships with target groups, gain their trust and respect; conflict management skills.

Work experience in an international organisation, an EU-funded programme, multicultural environment will be considered as an asset.

Staff of the Interact Programme facilitate the exchange of expertise, experience and good practices within the Interreg Programmes; i.e., European Territorial Cooperation (ETC) Objective, as well as other cooperation initiatives. The Programme's wide geographic scope covers the Member States of the European Union, plus Norway, Switzerland and neighbouring countries. Interact is co-financed by the European Regional Development Fund (ERDF) and by national contributions from participating countries.

The coordination framework and implementation structure of the Programme is based on a decentralised model consisting of a central Managing Authority/Interact Secretariat located in Bratislava (Slovakia), and four Interact Offices located in Valencia (Spain), Viborg (Denmark), Vienna (Austria) and Turku (Finland).

Regarding work experience information in your CV, you may wish to indicate a contact person we can approach for references on your employment. All applications will be treated confidentially, and referees will not be contacted without prior agreement with the applicant.
